### **Eligibility**

This iteration of the SEA Travels Giveaway #1 (the “Promotion”) is only open to individuals who have reached the legal age of majority in the jurisdiction in which they reside or age 21 (whichever is greater) and are legal CITIZENS and RESIDENTS of the following countries (herein “Eligible Countries”):

#### **Australia**

**\*United States of America**

**\*Including the District of Columbia,**

**but excluding Alaska, Florida, Hawaii, New York, & Rhode Island**

Individuals must have valid Passports issued by the aforementioned countries in which they possess citizenship and legally reside in said country at the time of entry. For example, a US Citizen who legally resides in Australia at the time of a giveaway is **NOT** eligible for entry. This is to avoid issues involving jurisdiction or travel visa issuance (if so required). The Promotion is not open to those in jurisdictions where prohibited or where the entrant is otherwise prohibited from entry set forth herein. CB Modeling LLC (“Sponsor”), RandomPicker.com (“Promotion Administrator” or “Administrator”), and their respective affiliates to include members of their immediate families (such as spouse, biological, adoptive, and step parents, grandparents, siblings, children, and grandchildren and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the aforementioned persons are **NOT** eligible to participate in the giveaway. Provide ALL requested information in the Entry Form. Any incomplete, omitted, or false information (or misinformation) entered into the form (whether intentional or not) is grounds for the voiding of the entrant’s submission, solely at the discretion of the Sponsor and/or the Promotion Administrator and will be handled on a case-by-case basis.

### **LIMIT ONE (1) ENTRY PER ENTRANT**

By providing your contact information, you consent to receive marketing information and communications regarding this and future giveaways from either the Sponsor or the Promotion Administrator (whether automated or not).

### **Additional Terms**

Each entrant is limited to one (1) entry. This is based and determined by the entrant and their association with the passport issued by their country. The information requested at the time of entry by the Promotion Administrator is intended to establish and create a unique submission per entrant, preventing multiple submissions by the same entrant or multiple unique submissions that represent the same entrant. If the Sponsor or Promotion Administrator determine that an entrant has attempted to avert or circumvent any security measure in place, all associated entries for the Promotion will be voided & the entrant will be disqualified from the Promotion, regardless if by accident or intent.

### **Platform Requirements**

YouTube will be the primary platform used to promote this Promotion. The following YouTube Platform Requirements were followed:

### **Entry Form Requirements**

To ensure a fair and secure promotion, all Entrants must complete the official entry form at <https://app.randompicker.com/enter/892272x46778> with 100% accuracy.

### **Purpose of Data Collection**

The personal information collected is used solely for the following administrative and legal purposes (the "Primary Purposes"):

- **Unique Identity Verification:** To enforce the limit of one (1) entry per person and ensure that no duplicate entries are accepted.
- **Winner Identification:** To confirm that the individual who submitted the entry is the same natural person to whom the prize documentation will be awarded.
- **Bot & Fraud Prevention:** To verify human status and preserve available entrant slots for real human participants.
- **Age Confirmation:** To establish a reasonable inference that all participants have reached the minimum required age of 21.

### **Five (5) Required Entry Fields**

1. **Surname:** Must be entered exactly as it appears on your valid, government-issued passport.
2. **Passport Issuing Country:** Entrants must specify their country of citizenship using the 3-letter International Standards Organization (ISO) code (e.g., **USA** or **AUS**).
3. **Month/Year of Birth:** Must be provided in **MMM/YYYY** format (e.g., JAN/1980).

4. **Qualifying Email Address:** Entrants must be the **Authorized Account Holder** of the provided email address.
5. **Humanity/Logic Question:** Entrants must correctly answer a skill-testing question to confirm human status.

#### Data Integrity & Disqualification

- **Zero-Tolerance for Email Aliases & Fraudulent Methods:** The use of email aliases, "plus-addressing" (e.g., name+extra@email.com), temporary/disposable email services, or any third-party "sweepstakes entry" services to circumvent the entry limit is strictly prohibited. Discovery of such activity—at any point during or after the Promotion Period—will result in the **immediate disqualification of ALL associated entries** and a permanent ban of the Entrant from all current and future promotions managed by the Sponsor.
- **Accuracy & Malformed Information:** To maintain the integrity of the random draw, entries must be 100% accurate. Any fields left blank or containing false, mistyped, or malformed information (including non-standard date formats or the use of "dummy data" such as "asdf" or "1234") will render the entry **immediately void** at the sole discretion of the Sponsor.
- **Verification of Identity (Winner Validation):** Selection as a "Potential Winner" is contingent upon verification of the Entrant's identity. The Sponsor reserves the right to request a **redacted copy of the Entrant's valid government-issued passport photo page** to verify that the Surname and Passport Issuing Country provided at the time of entry match the Entrant's legal travel documents exactly. Failure to provide this documentation within the 45-day verification window, or any discrepancy between the entry data and the passport, will result in forfeiture of the Prize.
- **Non-Marketing Use:** Information provided in the five required fields is used exclusively for the administration, security, and fulfillment of this Promotion. This data will **not** be used for marketing purposes or shared with third parties for promotional use unless the entrant provides separate, explicit consent elsewhere.
- **Finality of Decisions:** All decisions regarding the validity of an entry, the presence of fraud, or the interpretation of "malformed data" are made at the sole discretion of the Sponsor and are final and binding in all respects.

#### Drawing and Announcement Facilitation

##### RandomPicker.com

RandomPicker is an independent system that helps organizers conduct drawings from a random basis. It is used to pick winners of giveaways, sweepstakes, raffles or other competitions. Use of RandomPicker provides for random winner selection, online publishing of unbiased drawing results, an entrant search so that participants can verify their inclusion in the drawing, & the anonymous public listing of entries. Additionally, RandomPicker has a number of measures in place to prevent cheating and ensure fair outcomes.

The drawing will consist of ten (10) selections. The first entrant drawn will be listed as the “WINNER” of the Promotion, with the other nine (9) entrants listed as “ALTERNATE WINNERS” or “ALTERNATES”, with each of the nine (9) entrants being ranked from two (2) to ten (10) based on the order in which they were drawn. If the WINNER does not successfully complete the Winner Verification Process for any reason or it is determined that the WINNER is disqualified from claiming the prize for any reason, then the Sponsor will move to the first ranked ALTERNATE, and allow that entrant to also complete the Winner Verification Process. If that ALTERNATE also fails to successfully complete the Winner Verification Process, or is disqualified for any reason, the next ALTERNATE will be contacted until the listing of all 10 entrants have been given an opportunity to complete the Winner Verification Process.

NOTE: ALTERNATES WILL BE GIVEN A MODIFIED TIME FRAME THAT IS SHORTER THAN THE INITIAL QUALIFICATION SUBMISSION PERIOD OF FORTY-FIVE (45) CALENDAR DAYS. ANY TIME FRAME PROVIDED WILL BE SET ON OR AFTER THE DEADLINE DATE PROVIDED TO THE INITIAL WINNER AND WILL BE A MINIMUM OF FIVE (5) CALENDAR DAYS FOR EACH ALTERNATE CONTACTED, WITH THE DEADLINE FOR COMPLETION OF THE VERIFICATION PROCESS CLEARLY STATED IN THE COMMUNICATION RECEIVED BY THE ENTRANT FROM THE SPONSOR. **FOR THIS REASON, ALL ALTERNATES ARE URGED TO BEGIN COLLECTING THE ITEMS OUTLINED IN THE WINNER VERIFICATION PROCESS IN THE EVENT THAT THEY ARE CONTACTED AS AN ALTERNATE, AS A PRECAUTION.**

### **Winner Verification Process**

The Winner and Alternates, which from here out will be referred to as "Selected Travelers", will be expected to undergo a Winner Verification Process and to provide proof of performing or obtaining the following:

- A valid, unexpired passport issued by the country in which they possess citizenship and residency. The full legal name on the passport must match the name submitted **on** the entrant’s entry form. Additionally, the passport must remain valid for at least six (6) months **prior** to the expected travel date, as many countries deny entry if a passport expires within six months of the trip. This verification check must be 100% accurate as a countermeasure to protect the Sponsor and Promotion Administrator from fraud. The Sponsor will not store the passport image longer than necessary to verify the name and expiration date.
- Qualify for the United States' Trusted Traveler Program, such as Global Entry Program. This serves as a protective measure for both the Sponsor & Promotion Administrator since financing is being provided to the Selected Traveler's international travel, and any connections to individuals who are actively, or previously, involved in criminal activity that their country finds significant enough for their country to deny them approval for the Trusted Traveler Program, should be avoided. The acceptable programs per a Selected Traveler's citizenship are:

In the event a Selected Traveler is denied TTP status or does not wish to apply, the Sponsor reserves the right (but not the obligation) to allow the traveler to undergo an equivalent private background check at the traveler's expense. Any private background check performed in lieu of TTP status must be conducted by a Sponsor-approved, third-party investigative agency that is FCRA-compliant (for U.S. residents) or holds National Accreditation (for Australian residents), ensuring the screening meets equivalent government standards for criminal history and security vetting. If the traveler fails to provide a 'clean' report from a Sponsor-approved third-party agency within the Qualification Period, the traveler will be deemed ineligible. For the purposes of this Promotion, a 'clean' report is defined as one showing '**No Disclosable Court Outcomes**' (**NDCO**) in Australia or no felony convictions/disqualifying misdemeanors (as determined by the Sponsor's security standards) in the United States.

- An official letter from your employer confirming consecutive employment for at least twenty-four (24) months as of the end of the Qualification Submission Period. This letter should only confirm **tenure**, not income.
- Either a bank statement or a letter on official financial institution letterhead confirming your account balance during the Qualification Submission Period. For your protection, you **must black out or redact** all account numbers and specific transaction histories before submission. The Sponsor only requires proof of the **existence** of an account and the **available balance**. All financial verification documents will be used solely for the purpose of winner qualification and will be securely destroyed or deleted immediately following the conclusion of the Promotion Period, in accordance with applicable privacy regulations. Please refer to the **Privacy** section of these Official Rules for information regarding the **Sponsor's Safe Harbor** and the immediate deletion of any non-redacted or non-compliant sensitive documentation received.
- Proof of Address provided either by address shown on Government issued identification, official letter from a Government operated Postal Service stating the Selected Traveler's recorded address on file, or the address listed for the Selected Traveler from their employer or financial institution from the aforementioned 'Proof of employment and deposits' item in these Official Rules.
- Acknowledgment of potential Gift Taxes. Depending on the Selected Traveler's jurisdiction of residence and the price of the airfare, they may be subject to pay gift taxes for claiming the prize. At their sole discretion, the Sponsor will provide the Selected Traveler with all Gift or Tax forms required for verification, but that does **NOT** mean additional Gift or Tax forms will be required per law. **AUSTRALIAN WINNERS:** You **MUST** redact your Tax File Number (TFN) from all financial or government documents. Under the Privacy Act 1988, it is a specialized requirement that TFNs are not shared with unauthorized parties. Failure to redact your TFN will result in the immediate deletion of your document per our Privacy Policy.

### **Prize Conditions, Verification, and Tax Obligations**

All potential winners are subject to verification by the Sponsor or Promotion Administrator. As part of the Winner Verification Process, potential winners must execute an Affidavit of Eligibility and provide all required tax documentation. **For U.S. Residents:** A completed IRS Form W-9 is required; a Form 1099-MISC will be issued for the tax year in which the prize is awarded. **For Australian Residents:** Winners are responsible for complying with Australian Taxation Office (ATO) requirements regarding any assessable income.

If a potential winner has won a prize in any Sponsor-conducted promotion within twenty-four (24) months of the start of this Promotion, they will be disqualified. The prize is a single, round-trip, airline ticket to Ninoy Aquino International Airport in Manila, Philippines (ARV <\$1,000 USD). Any difference between the stated ARV and the actual ticket cost at the time of booking will not be awarded as cash or credit. Winners are solely responsible for all expenses not specifically mentioned, including but not limited to: valid passports, visas, travel insurance, ground transportation, and meals. Failure to complete the verification process or provide tax forms will result in forfeiture and may lead to a permanent ban from future promotions.

### **Approximate Retail Value (ARV)**

The Approximate retail value depends upon the flight offerings offered by the airline, ticket dates, and airports departure & destination. The approximate retail value of an airline ticket from an eligible airport of departure (see the “**Additional Terms for Grand Prize Winner & Alternates**” section) to Manila, Philippines is less than \$1000 USD. Any difference between this approximation and the actual ticket awarded will not be charged to the Entrant, nor refunded.

### **Notification of Winner or Alternate Selection**

All entrants selected either as the Winner or an Alternate will receive **ONE (1)** official email from the Sponsor sent **ONLY** to the email address provided by the entrant during the Entry Submission from [info@CBModeling.com](mailto:info@CBModeling.com) - **NO OTHER EMAIL ADDRESSES PROVIDED BY THE ENTRANT OR MEANS OF COMMUNICATION WILL OCCUR OR BE CONSIDERED AS A MEANS OF CONFIRMATION OF SELECTION.**

**ALL ENTRANTS WILL HAVE FOURTEEN (14) CALENDAR DAYS FROM THE DATE THE EMAIL IS SENT TO RESPOND VIA EMAIL AND ACCEPT THEIR PLACEMENT AS A WINNER OR ALTERNATE. FAILURE TO RESPOND WITHIN THIS TIME WILL RESULT IN DISQUALIFICATION. THIS IS SEPARATE FROM THE TIME FRAME FOR CLAIMING THE PRIZE.**

The Drawing Record will order all entrants during the drawing. The first entrant listed will be the Winner with the following nine (9) being the Alternates. These ten (10) entrants will be on the Winners List. Reserve Alternates will be identified on the Drawing Record starting at the entrant numbered eleven (11), which is the first entrant listed on the Drawing Record **AFTER** the last entrant listed on the Winners List. These Reserve Alternates will only be privately contacted and subsequently publicly announced if the initial Winner and all Public Alternates fail to respond or qualify within their respective fourteen (14) day response windows. All records of the drawing will be held for a minimum of twelve (12) months to satisfy audit requirements.

### **Additional Terms for Grand Prize Winner & Alternates**

Travel dates and airports of departure and airports of destination are subject to availability. The round-trip airline ticket will be obtained from Philippine Airlines (PAL), with a required airport of destination of Ninoy Aquino International Airport (MNL). The following airports are eligible for departure, based on the Selected Traveler's citizenship/passport:

The Selected Traveler is solely responsible for any and all costs, expenses, and arrangements involved with traveling to the airport selected as the airport of departure for the awarded ticket, and any additional airline fees, surcharges, lodging or ground transport charges, meals, incidentals, gratuities, service or facility charges, personal charges, security fees, taxes, and any other expenses or any other flights to other airports while traveling. All flight offerings, to include flight times, airports of departure, and airports of destination are determined by Philippine Airlines and are **NOT** controlled or influenced by the Sponsor nor Promotion Administrator. Determination of which of the mentioned airports of departure is selected on the awarded airline ticket solely rests with the Sponsor. The Sponsor will inquire which airport of departure the Selected Traveler prefers, but that does not ultimately determine whether said airport will be selected for departure. The Selected Traveler may be required to provide or present Philippine Airlines with a major credit card in connection with the flight to cover additional expenses related to travel.

The awarded ticket must have a flight date between Friday, June 19, 2026 and Friday, July 10, 2026 and will be for a maximum period of ten (10) days, depending on flight availability. Any inability to travel within this time frame will result in forfeiture of the prize. The Sponsor will book the ticket once the Winner Verification Process is completed successfully. The Sponsor solely retains the right to determine the duration and flight dates on the tickets, given this time frame. Any modifications to this time frame will be provided to the Winner in writing by the Sponsor. Once the ticket is awarded, **NO FLIGHT DETAILS WILL BE CHANGED BY THE SPONSOR**. This includes airports of departure, airports of destination, flight times, seating arrangements, flight dates, meal plans, or any additional upgrades. The Selected Traveler will deal directly with Philippine Airlines and solely be responsible for any changes that occur. This includes flight changes, delays, or cancellations that occur at the discretion of Philippine Airlines.

All mentioned, unmentioned, or any unforeseen arrangements associated with obtaining and awarding the airline ticket are at the Sponsor's sole discretion. The Sponsor also reserves the right to award the ticket on a different airline and modify the available airports of departure depending upon the service offerings of the pre-selected or replacement airline, at the Sponsor's sole discretion.

**Optional Personal Interaction & Independent Activities**

At the Selected Traveler's request, a representative of the Sponsor may offer to meet the traveler for a personal tour or social interaction. Entrant acknowledges that any such interaction is **entirely optional** and does not constitute a part of the official Prize. The Sponsor makes no guarantees regarding the availability or conduct of any representative. Any activities undertaken during such a meeting are performed at the Selected Traveler's own risk. The Sponsor and Promotion Administrator expressly disclaim all liability for any injury, loss, or damage arising from these independent, non-promotion activities.

In the event the Selected Traveler participates in any optional personal interaction or tour with a representative of the Sponsor, the Sponsor may request consent to photograph or video record the interaction for use on the Sponsor's social media channels (e.g., YouTube, Instagram). The Selected Traveler acknowledges that:

- **Consent is Optional:** Granting permission with a signed Media Release Form to be recorded is **not a condition** of receiving the Prize or participating in the optional interaction.
- **Revocation:** The Traveler may decline to be recorded or withdrawn their consent at any time during the interaction.
- **Usage Rights:** If consent is granted, the resulting media will be subject to the "Publicity Release" terms of these Official Rules, allowing the Sponsor to edit, post, and monetize the content without further compensation.

### **Conduct and Legal Compliance**

**Adherence to Laws and Regulations:** The Selected Traveler must comply with all applicable federal, state, and local laws of their country of citizenship and residence. Additionally, the Selected Traveler is strictly required to abide by all national and local laws of the Republic of the Philippines while traveling. This includes, but is not limited to, full compliance with:

- **Customs and Immigration:** All regulations regarding the transport of goods, currency, and restricted items into or out of the United States, Australia, and the Philippines.
- **Visa and Health Mandates:** All entry requirements, health certifications, or government-mandated protocols required by the Philippine government; failure to obtain or follow these will result in prize forfeiture.
- **Carrier and Airport Policies:** All rules of Philippine Airlines (PAL) and the regulations of Ninoy Aquino International Airport (MNL).

**Impact of Misconduct:** The Sponsor and Promotion Administrator reserve the right to verify the eligibility of any entrant at any time. Because the Selected Traveler must qualify for a U.S. Trusted Traveler Program (e.g., Global Entry) to prove they are not involved in criminal activity, any subsequent legal infraction or arrest during the Promotion Period or travel duration is grounds for immediate disqualification.

- **Disqualification:** Any violation of law or failure to complete the verification process accurately may result in the forfeiture of the prize and a permanent ban from all future promotions.
- **Liability Release:** The traveler agrees to release and hold harmless the Sponsor and Promotion Administrator from any and all claims, demands, or causes of action arising out of the traveler's own actions or failure to comply with the laws of any involved jurisdiction.
- **Financial Responsibility:** The Selected Traveler remains solely responsible for any fines, legal fees, or unforeseen expenses resulting from their conduct during the trip.
